To Meet All Accreditation Requirements, the Course Student must:

- ⇒ attend the course
- ⇒ complete the Assessment Workbook to a satisfactory standard including a practical assessment. All sections are to be signed off by a Silver or Gold Licence Coach
- ⇒ be a current ASCTA member
- ⇒ have undergone a Nationwide Police Check within the past 3 years

Recognition of Current Competency (RCC):

Some potential Course Students may be able to satisfy all or some of the competency requirements for accreditation without having to attend the entire formal course.

The RCC application kit can be obtained from SwimEd, email coaching@SwimEd.com or phone 07 5494 9649 if you think this applies to you. Complete and return the information along with the Recognition of Current Competencies (RCC) application fee of \$40 to SwimEd. The application will then be assessed. Further fees are payable if the application is successful (minimum \$100).

To participate, Course Students should:

- ⇒ read the Terms and Conditions and complete the Enrolment. Send with payment as listed below.

Language, Literacy and Numeracy: Students should contact SwimEd if extra assistance is required. An extra fee may be charged.

Refunds, Transfers & Course Cancellations:

The Course Administrator should be contacted *prior to the course commencement* if you are unable to attend the Bronze Licence course. If the Course Administrator is administering another course at a suitable time and venue to all, you *may* be able to transfer to this course. Otherwise refunds will incur a 25% administration fee.
